VA Service Connected Compensation:

is a monetary benefit paid to veterans who are determined by the VA to be disabled by an injury or illness that was incurred or aggravated during military service.

- * Discharge must be under conditions other than dishonorable.
- * VA pays benefits in 10% increments.
- * Advocates assist in filing for VA benefits. (ADVS, ALG, VFW, DAV)

 A successful VA claim for compensation must include:

1. Proof of a chronic illness or injury in service (usually found in military service treatment records).

A current chronic medical diagnosis

Non-Service Connected Pension







is a monetary benefit paid to low income wartime veterans. *Criteria includes*:

- Other than dishonorable discharge;
- 90 days active duty or two years active duty after September 8, 1980;
- One day of war time service;
- over age 65 or permanently and totally disabled;
- low income; low net worth (Less than \$80,000)

^{*} Guard/ Reserve must complete time called to federal service.

War time Service for VA purposes

Mexican Border Period: May 9, 1916 through Apr 5, 1917

World War I: Apr 6, 1917 through Nov11, 1920 (with exceptions)

World War II: Dec 7, 1941 through Dec 31, 1946

Korean War: Jun 27, 1950, through Jan 31, 1955

Vietnam War: Aug 5, 1964 (Feb 28, 1961 for veterans who served :in

country" before Aug 5, 1964) through May 7, 1975

Gulf War: Aug 2, 1990 through a date to be set.

VA Health Care

- The VA operates the nations largest integrated health care system with more than 1,700 sites of care.
- Eligibility a person who served in the active military, naval, or air services and was discharged under other than dishonorable conditions may qualify for VA health care benefits.
- Guard/Reserve called up to federal service under Title 10 orders or line of duty disability.



The VA has implemented Priority Groups for enrollment in VA health care.

- 1. Service connected 50% or higher
- 2. Service connected 30 or 40%
- 3. Former POW's, Purple Heart, Medal of Honor, or service connected 10 or 20%



- 4. In receipt of Aid and Attendance, Catastrophically disabled
- 5. Non-service connected or 0% service connected, Pension, eligible of Medicaid benefits
- 6. Compensable 0% service connected, wartime and Camp Lejeune service 1957 - 1987
- 7. Income below geographical means test
- 8. Income above national income thresholds, must pay co-pays

Special Housing Adaptation (SHA) Grant

• The SHA grant can be used to increase the mobility of eligible veteran and service members throughout their residences. Veterans and service members with specific service-connected disabilities may be entitled to this type of grant, up to the current maximum of \$15,462.



SHA Grants Can Be Used To

Adapt a Home the Veteran or a Family Member Already Owns Adapt A Home the Veteran or a Family Member Intends to Buy Help A Veteran Purchase a Home Modeled to Their Needs

Special Adaptive Housing (SAH) Grant

• The SAH grant is designed to help disabled veterans by providing a barrier-free living environment, such as a wheelchair accessible home, that affords veterans a level of independent living they may not otherwise enjoy. Veterans and service members with specific service- connected disabilities may be entitled to a grant for the purpose of constructing or modifying a home to meet their adaptive needs, up to the current maximum of \$77,307.



SAH Grants Can Be Used To

Build A Home On Purchased Land, if It is Suitable for Disabilities or Special Needs Construct on Adapted Home On Land To the Bought Remodel on Existing Home to the Suitable For Disabilities or Special Needs Pay the Ungood Principal Mortagage Salance of an Adapted Home Previously Acquired withhout the Assistance of a VA Grant

Home Improvements Structural Alterations (HISA) Grant

This grant provides medically necessary improvements and structural alterations to veterans and service members' primary residence for the following purposes:

- Allowing entrance to or exit from their homes
- Use of essential lavatory and sanitary facilities (e.g. roll in showers or walk in tubs)
- Allowing accessibility to kitchen or bathroom sinks or counters (e.g. lowering counters/sinks)

Lifetime benefit up to \$6,800 may be provided for:

- Veterans and service members who have a service connected condition
- Veterans who have a non-service connected condition rated 50% or more
- Lifetime benefit up to \$2,000 may be provided for Veterans who have a non-service connected condition

Automobile Adaptive Equipment

- The Automobile Adaptive Equipment (AAE) program permits physically challenged persons to enter, exit, and/or operate a motor vehicle or other conveyance.
- Veterans are trained, through the VA Driver's Rehabilitation Program, how to safely operate their vehicle on our nation's roadways.
- The VA also provides necessary equipment such as platform wheelchair lifts, UVLs (under vehicle lifts), power door openers, lowered floors/raised roofs, raised doors, hand controls, left foot gas pedals, reduced effort and zero effort steering and braking, and digital driving systems.
- Automobile Allowance One time use \$20,235.20 eff. 10-1-16.

Death Benefits

- Death gratuity \$100,000 Military Service Org.
- Dependency Indemnity Compensation (DIC) *
- Parent Dependency Indemnity Compensation (Income Based)
- Death Pension Surviving Spouse Maximum annual income - \$721.00 and child \$944.00 per month)
- Burial Benefits Interment, plot, transportation reimbursement, flag, headstone/marker,
- No fee passports to visit American military cemeteries on foreign soil.







Dependency Indemnity Compensation (DIC)

Requirements:

- Veterans death due to service connected disability, or
- 100% service connected for over ten years –
 Surviving Spouse \$1257.95 per month, each dependent child \$311.64)
- 100% Total and Permanently Disabled eight years –
 Additional \$267.12 per month
- Aid and attendance –
 Additional \$145.99 per month

Dependent requirements:

- Must have been married to the veteran for at least one year prior to death.
- Or, must have been with child at the time of the veteran's death.

Up to \$2000.00 burial reimbursement

- The VA offers veterans and eligible surviving dependents VA Home Loan Guaranties.
- The VA Home Loan Department offers many other services to veterans and eligible dependents.
- A veteran or eligible dependent may obtain a Home Loan Guaranty to: Buy or build a home or condo unit; repair, alter or improve a residence owned by the veteran; refinance an existing home; install a solar heating or cooling system or other energy-efficient improvements.
- * Guard/Reserves must complete 6 years of service unless disabled.


