## Arizona Represented in U.S. House of Representatives Hearing on Veteran Employment During COVID-19 Era

May 26 Hearing Features Arizona Coalition for Military Families Director Thomas Winkel

**Phoenix, Ariz. (May 28, 2021)** – The support given to service members, veterans and their families by the Arizona Coalition for Military Families (ACMF) and its partners in the public and private sector was featured at a May 26 hearing by the U.S. House of Representatives Veterans Affairs Subcommittee on Economic Opportunity.

Chairman Mike Levin opened the hearing with an overview of the great strides that were being made to reduce veteran unemployment before the pandemic struck. With the goal of getting as many resources as possible to veterans and their families to ease the difficulties presented by the effects of COVID-19, Chairman Levin invited testimony by the panel members after remarks by Ranking Member Barry Moore.

Arizona Coalition for Military Families' Director Thomas Winkel provided the Subcommittee members with an overview of ACMF's efforts to address the unique challenges faced by the veteran workforce in today's labor market. One of the areas that ACMF's Be Connected Career Navigation program addresses is helping veterans translate the experience and abilities they gained through military service into the skills sought after by civilian employers.

"Our effort focuses on matching candidates to employers for the best possible outcomes, while addressing issues and barriers that might prevent career placement or progression. And because this effort works hand in hand with Arizona's workforce system we eliminate conflicts of interest and reduce the prevalence of underemployment by focusing on both quality and quantity of placements."

The ACMF's approach to supporting veteran employment and underemployment involves a collaborative approach that draws in public and private partners from across the state.

"Our partnership includes our Governor's Office and the Office of Youth, Faith & Family, U.S. Department of Labor, Arizona Department of Veterans' Services, Arizona Commerce Authority, Office of Economic Opportunity, Department of Economic Security, ARIZONA@WORK, our active duty, guard and reserve units, Chamber of Commerce, Veteran Supportive Campuses, and many more," said Winkel. "On the employer side, our Arizona Corporate Council on Veteran Careers is a Network of Veteran Supportive Employers who share how they strengthen their recruiting, hiring and retention of military-connected career seekers."
